PLEASE NOTE THAT BOTH MEMBERSHIP LEVELS ARE FOR INDIVIDUALS – THERE ARE NO LONGER ANY COMPANY/CORPORATE MEMBERSHIP LEVELS

PLATINUM MEMBER - \$175 (PRICE INCLUDES NAMB MEMBERSHIP FEE OF \$120 AND KAMP MEMBERSHIP FEE OF \$55)

Membership in this classification is open to any individual in the residential mortgage field that is validly and currently licensed as required by NMLS and the state(s) in which they operate. Platinum members have one vote in the affairs of KAMP and NAMB. This membership level also entitles the individual members to the NAMB Discount Package, No-Cost or Low-Cost NAMB webinars, 10% savings on all NAMB sponsored event registration fees, inclusion in the NAMB President and Government Affairs quarterly conference calls and access to NAMB web site "Members Only" page. Platinum members also receive discounted KAMP CE Class pricing. Membership is for a one year period from time of notification of membership by NAMB and KAMP and continues in force in the event the member changes employment with a particular company.

SILVER MEMBER - \$75 (PRICE INCLUDES NAMB MEMBERSHIP FEE OF \$50 AND KAMP MEMBERSHIP FEE OF \$25)

Please Read Carefully:

You will receive a separate membership notification from KAMP and NAMB. Each of these notifications will provide your membership number – a NAMB membership number and a KAMP membership number. Please keep these membership numbers handy – they will be needed for all your future registrations.

Your NAMB dues will be forwarded to NAMB on the day this form is received. You should receive both your KAMP and NAMB membership notification within 10 business days from the day you mail this application form. Please contact us at kmba@roadrunner.com in the event you do not receive your membership notifications within 10 business days.

KAMP is a professional association. Payment of organizational dues is generally deductible as an ordinary and necessary business expense. A portion of dues, however, is not deductible due to the extent KAMP and NAMB engage in lobbying. The non-deductible portion of dues for 2012 is estimated at 27%, which includes both KAMP and NAMB. Contributions or gifts are generally not deductible as charitable contributions for federal income tax purposes. Federal law prohibits the deduction from your taxes that portion of member dues allocated to federal lobbying activities.
